The Regional Practice Coordinators who provide consultancy and support to professionals around all areas of trafficking and exploitation who will refer to themselves as Independent Child Trafficking Guardian- Regional Practice Co-ordinators (ICTG RPC's). ICTG's support all potentially trafficked children up to 18 years of age through direct and indirect support.</p> <p><b><u>The Role of the Independent Child Trafficking Guardian's (ICTG's)</u></b></p> <p>One-to-one ICTG's will provide support on an individual basis to trafficked and potentially trafficked children within the Early Adopter Sites where there is nobody who has effective parental responsibility for that child.</p> <p>This includes:</p> <ul style="list-style-type: none"> <li>• Any child from outside the UK who is separated from their family or any person who has parental responsibility for them</li> <li>• Any child from outside the UK whose parents, or those assuming parental responsibility for them, are suspected as being involved in their trafficking. ICTG support is offered as part of a multi-agency safeguarding approach and includes one to one support for young people, alongside support for professionals involved with their care.</li> </ul>	

			<p><b><u>The Role of the ICTG Regional Practice Co-ordinator (RPC):</u></b>  The RPC will work with professionals to support them in recognising and responding to exploitation and trafficking for internally trafficked children.  They will offer individual case consultation for professionals delivering direct work, with a focus on safeguarding within the context of exploitation; and will support in the submission of referrals to the National Referral Mechanism. They will contribute to best practice and strategy development; and support professionals through training and awareness raising sessions to staff teams.</p> <p><b><u>The role of the 24/7 ICTG Support Line:</u></b>  We offer a 24/7 support line for all ICTA early adopter sites; providing consultation, advice &amp; guidance to professionals who have trafficking concerns for any young person who is a potential victim of trafficking including guidance on immediate safety planning. Referrals for young people eligible for direct work will be allocated to an ICTG who will make contact with the young person within 24 hours to offer support; they will offer specialist trafficking support for professionals involved with the young person’s care. Referrals for young people eligible for indirect work will be allocated to the ICTG RPC who will offer specialist trafficking and exploitation support for professionals involved in the young person’s care.</p>

IMSAs work to ensure survivors are aware of and have access to their legal rights and entitlements and will conduct a thorough assessment of their advocacy and support needs. This considers safety and security; mental and physical health needs; training, education and work; challenging NRM decisions and other public law issues; welfare benefits and finance; identity theft and debts from trafficking; criminal convictions from trafficking; housing and homelessness; immigration; criminal and civil justice processes; etc. IMSAs work in partnership with the survivors and other organisations / legal representatives to overcome barriers and achieve outcomes set by the survivor.</p> <p>Hope for Justice also have an IMSA embedded within Jericho Foundation in Birmingham (see Jericho Foundation table for contact details).</p> <p>The Advocacy team also offers an advice service that provides tailored and specialist advice and signposting on survivor care in the UK to other organisations and/or survivors. IMSAs may be able to intervene around a specific matter and/or outcome (e.g. welfare benefits reconsiderations, pre-NRM advocacy, etc.) or work alongside an agency who has reached out with an enquiry.</p>
